24/022 Election of Chair

Cllr Bottwood asked for nominations for Chairman. Cllr Armstrong was willing to take on the Chair position. Proposed Cllr Freeman seconded Cllr Bottwood All agreed.

24/023 Chairman to sign Acceptance of Office form

Cllr Armstrong signed the Declaration of Acceptance of Office form and was elected the new Chairman.

24/024 Election of Vice Chair

Cllr Armstrong then took over the meeting and asked for nominations for Vice Chairman for the Council.

Cllr Bottwood offered to stand as Vice Chairman. This was proposed by Cllr Freeman and Seconded by Cllr Armstrong. Agreed by all.

24/025 Vice Chair to sign Acceptance of Office form

Cllr signed the Declaration of Acceptance of Office form and was elected the new Vice Chairman.

24/026 Newly elected council to sign Acceptance of Office forms

The outstanding councillors then signed their individual Acceptance of Office forms.

24/027 Update on the co-option of additional Councillor

Cllr Armstrong then went on to explain that as there were only 6 councillors elected as from June the council can now co-opt another person to the parish council.

There had been 3 people that initially showed an interest. One has followed up pro-actively since then. This person will be invited to come along and be co-opted at the next meeting.

24/028 Welcome and apologies of absence

Cllr Armstrong welcomed everyone to the meeting and stated there had been no apologies of absence.

Thanks was given to ClIr Bottwood for his long years of service to the PC, his three years of strong chairmanship and his willingness to stay on now to help smooth the transition to a new Council team.

The Annual Assembly this year is on the 1st June.

The expansion of the children's play area is one of the main project successes over the past year. Cllr Ogawa was thanked for her hard work developing various successful village events over the year.

Cllr Piper-Hunter was welcomed to the team and gave some background information about himself.

24/030 Committee Structure for 24/25

As there is still a vacancy for a parish councillor at the moment, the new committee structure will be decided once a new councillor has been appointed. The current committee structure and representatives will remain unchanged until then. The council was asked for thoughts and ideas about current and prospective committee structures. There was a broad consensus that the current approach was working well and did not warrant any radical changes.

Cllr Armstrong stated that the chair or vice chair of the Parish Council had in the past been the representative for these two bodies and could see no reason why this should change. Cllr Bottwood would therefore continue with this role. The chair of the Recreation Ground committee was asked whether they were happy for the Recreation Ground representative on the Langham Community Centre Trustees body to remain unchanged. This was confirmed and Bob Schofield was asked whether he was prepared to continue in this role. This received a positive response from Bob Schofield. It was proposed by Cllr Ogawa seconded by Cllr Piper-Hunter that Bob Schofield continue. All agreed.
